Ms. Sneha Katkar Ma'am, gave all the information related to cyber-crime with examples and what precautions one can take to avoid such incidents that she explained.

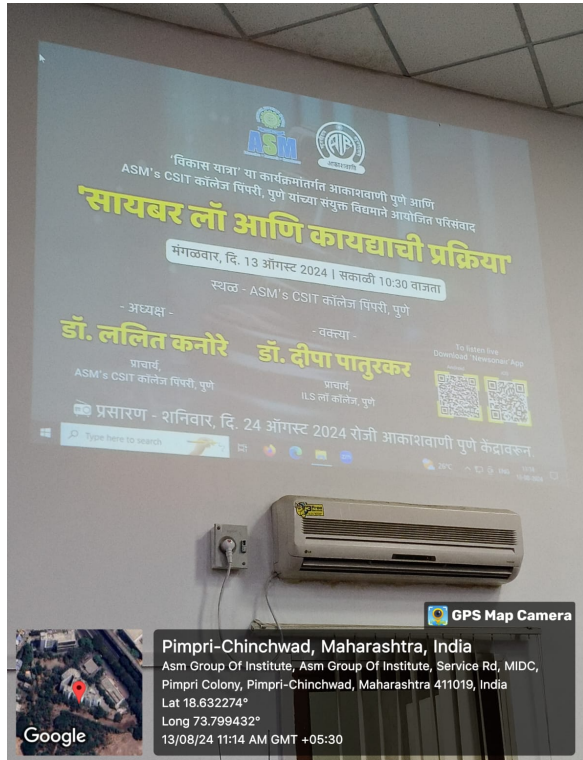
Dr. Lalit Kanore sir, Principal of CSIT also spoke about Cyber-crime cases and monetary losses occurred due to cyber crime in India.
