The Principal of the College has tendered the letter dated 10/05/2023 seeking withdrawal of the proposal for approval of fees of B.Pharm and M.Pharm courses for the academic year 2023-2024, as the Management running the Institute has decided to continue to charge the fees for the academic year 2023-2024 as approved for the academic year 2022-2023.

Considering the reason assigned and particularly the Review Application filed by the Institute against the decision of finalization of fees for the academic year 2022-2023 in respect of said courses being disposed of on 10/05/2023, it was decided to allow the Institute to withdraw the proposal.
